On January 25, 2021 (New York time), the Company granted a total of 22,950,500 Awarded Shares to selected Award Participants pursuant to the 2021 Share Award Scheme adopted by the Company on January 22, 2021. Of the 22,950,500 Awarded Shares, (i) 19,850,500 Awarded Shares were granted to 182 Non-connected Award Participants, all being employees of the Group who are not connected persons of the Company; and (ii) 3,100,000 Awarded Shares were granted to two Connected Award Participants and were approved by the independent shareholders of the Company at its annual general meeting held on May 27, 2021.
